- Glazing Material: The glazing material used in these units was ¼" annealed glass with Vista 8 12.1 Mil Solar film.
- Glazing Method: Each glass lite used in these units were glazed using the following (typical) 12.2 procedures:

Interior Side: 1/2" x 1/2" bead of LLUMAR EDGE GRIP™ (Tremco Proglaze SSG) silicone on top of a 5/8" x 1/2" glazing stop that snapped into place along the sill.

Exterior Side: Glazing gasket (Part #E2-0052).
